# INSTRUCTION SHEET FOR TRANSMISSION KITS 8000, 8001, 8002, 8003, 8004. WITH PRECISION CUT GEARS



Thank you for purchasing one of the finest transmission assemblies available. You will need to install the clutch cable, clutch release bearing, and release pushrod by removing the screws with a 3/16" allen wrench from the side cover in order to gain access to clutch cable coupling. Install cable per Harley Davidson<sup>®</sup> Service Manual. Use the gasket for cover included with your transmission. Torque screws to Harley Davidson<sup>®</sup> specifications of 7-9 foot lbs of torque in a criss cross pattern. Transmissions are shipped complete. If your transmission has the main seal, spacer and pulley installed, disregard the information on installing pulley. The main seal will need to be installed for the final drive sprocket you will be using. If you are going to use a Harley Davidson<sup>®</sup> pulley kit No. 40210-85D, it will come with a spacer, seal, lockplate and (2) lock screws. This is the latest from Harley Davidson<sup>®</sup>. Use JIMS<sup>®</sup> tool #2260 sprocket locker to block sprocket at the final torque of 110-120 foot lbs. (Not to exceed 150 foot lbs.) See service manual. JIMS highly recommends the use of our mega nut

No.1708. Press bearing race #34091-85 on to mainshaft using JIMS<sup>®</sup> tool #34902-84 bearing race tool. Follow the instruction with tool. Next install 20-24 ounces of Torco 80w-90w gear oil (Supplied with trans or equivalent). Caution: JIMS<sup>®</sup> recommends synthetic oils only after your transmission has 500 or more miles, this will allow the bearings to establish a wear pattern. Change transmission lube after the first 500 miles and every 5000 miles there after.
