Note: The following installation instructions assume that you have already installed the appropriate splined adapter for your specific application.

STEP 1

Read and understand all steps in the instructions before starting the installation. Park the motorcycle on a hard, level surface and turn off the ignition. Let motorcycle cool.

STEP 3 Refer to PIC 2. Place the splined section of the back plate over the splined adapter; adjust the angle of the back plate and secure it with the supplied 5/16 -18 X 1.00 Flange Hex Head. Place the license plate frame onto the black plate to confirm desired position of the assembly.

Remove the license plate frame from the black plate and fully tighten the screw; ensuring that the splines on the mount mesh properly with the splines on the backing plate.

Note: Be sure the plate assembly does not interfere with the shock absorber or other components on the motorcycle and that there is sufficient clearance for the passenger foot peg.

STEP 4 Refer to PIC 3. Feed the wires of the license plate frame through the hole located by the spline mount of the back plate.





STEP 5 Refer to PIC 4. Install your license plate into the assembly. You may need to trim your plate with tin snips for a perfect fit and for wire harness clearance between the license plate frame and back plate.



STEP 6 Refer to PIC 5. Locate two (2) Cup Point Screws. Secure the license plate frame to the back plate by fastening these screws into the bottom of the assembly.

STEP 7 light, or refer to the factory service manual to identify which wire

Locate the main wiring harness running to the rear fender. Use a test performs the run function of the taillight and which wire is the ground wire. Mark these wires for reference.

Route the plate assembly wiring harness to the stock wiring harness. Keep the wiring harness clear of moving parts and high temperature parts (belt, wheel, swing arm pivot, etc.).

SECURE ALL WIRING AWAY FROM ANY MOVING PARTS. PINCH POINTS OR EXTREME HEAT. KURYAKYN WILL NOT ISSUE A WARRANTY ON ANY ELECTRICAL COMPONENT THAT FAILS DUE TO PINCHED, CRIMPED, BROKEN, ABRADED, MELTED OR FRAYED WIRES.





STEP 9

Refer to FIG 1 below to make the correct electrical connections.

Refer to PIC 6, 7, and 8. Install one of the supplied Female T-Taps to the running light wire determined in Step 7. Install one of the supplied Male connectors to the RED wire from the Plate light. Plug the Male Connector into the Female T-Tap.





**STEP 10** 

Install one of the supplied Female T-Taps to the ground wire determined in Step 7. Install one of the supplied Male connectors to the BLACK wire from the Plate light. Plug the Male Connector into the Female T-Tap.

**STEP 11** 

Secure the plate assembly wiring harness using the supplied cable ties. Reconnect the battery cables and test the license plate assembly and taillight for proper function.

Note: If the license plate rattles in the frame, install the supplied self-adhesive tape to the inside of the back plate then re-install the license plate. This should eliminate the rattle.
