

### **INSTALLATION OF THE FOLDING BOARDS**

- **STEP 2** Remove the existing footpegs and install the splined adapters (sold separately) onto the footpeg mounts using the stock hardware. Refer to the specific instructions included with the splined adapters.
- **STEP 3** Locate provided Right (brake) Side Folding Board. Align and test fit the position of the Folding Board. Determine which of the three splined mounting holes best suits you before continuing on.
- **STEP 4** Locate provided one (1) screw and flat washer. Place the washer onto the screw.
- **STEP 5** Refer to PIC 3. Align and place the Folding Board on the footpeg adapter. Fasten the board to the adapter using the screw and flat washer assembly. Ensure the splines on the board and adapter are engaged. Fully tighten hardware.
- **STEP 6** Ensure that the board is able to fold upward.
- **STEP 7** Repeat Steps 3 through 6 for the Left (clutch) Side Folding Board.

### ADJUSTING THE FOLDING BOARDS

- **STEP 8** Loosen (but do not remove) the screw. Adjust the angle of the board to the desired position. Ensure that the splines are engaged and retighten the screw.
- **STEP 9** Fold the board up and ensure that it does not contact any part of the bike. Adjust if necessary.
