WARRANTY

All Legend ® Suspensions' parts are guaranteed to the original purchaser to be free of manufacturing defects and workmanship. Parts that fail to conform to these conditions will be repaired or replaced at Legend ® Suspensions' option if the parts are returned to Legend ® Suspensions by the original purchaser. Delivery of the original purchase invoice or receipt loang with the part of the parts are returned to Legend ® Suspensions by the original purchase reginal purchase invoice or receipt loang with the part of the legend ® Suspensions is a condition precedent to Warranty coverage. Warranty coverage is limited lifetime.

nt the original purchaser believes warranty service is required, the original purchaser must call or e-mail Legend ® Suspensions immediately to concern. Some concerns may be rectified by a telephone call and need no further course of action.

A part that is suspect of being defective must not be replaced by a Dealer or any other person without prior written authorization from Legend ® Suspensions. If it is deemed necessory for Legend ® Suspensions to make an evaluation of the part to determine whether a defect exists, a return authorization number (RA#) must be obtained from Legend ® Suspensions by the original purchaser. Properly obtaining a return authorization number from Legend © Suspensions is a condition precedent to Warranty coverage.

The part must be packaged properly so as to not cause further damage and be returned prepaid to Legend ® Suspensions with a copy of the original invoice or receipt of purchase. If other evaluation, Legend ® Suspensions finds the part to be defective, Legend ® Suspensions will repair or replace the part, of the discretion and option of Legend ® Suspensions.

Should either party bring a dispute in a forum other than AAA, the arbitration may oward the other party its reasonable costs and ense, including altorney fees and disbursements incurred in staying or dismissing such other proceedings or in otherwise enforcing compliance with this dispute resolution provision.

INSTALL INSTRUCTIONS



STEP ONE: REMOVE BODY

A. Refer to the H-D Service Manual for removal instructions or take your trike to an authorized dealer.



STEP TWO: REMOVE OEM MOUNTING BRACKETS

- A. Place a jack under the main frame of the trike and raise it until the rear tires are just off the floor.
- B. Remove both left and right upper shock mounting bolts, then rotate the shocks to the rear to prevent interference in the next step.
- C. Lower the jack until the lower shock bolts are exposed above the sub-frame assembly.
- D. Remove both left and right lower shock bolts.
- E. Once the shocks are free, reinstall the upper shock bolts to hold shocks in place.
- F. Remove the two mounting bolts from the parking brake bracket on the LH side of the trike. FIGURE A
- G. Remove the three bolts from the LH and RH shock mount brackets and remove the OEM brackets. FIGURE B



STEP THREE: INSTALL LEGEND LIFT BRACKETS

- A. Identify LH (102-1128) and RH (102-1127) Legend Lift Brackets. FIGURE C (logos will face outwards toward the rear tires)
- B. Apply blue Loctite to all the OEM hardware. FIGURE D
- C. Install Legend Lift Brackets, tighten bolts evenly to final torque of 45 ft/bs. FIGURE B & E
- D. Remove the upper shock bolts.
- E. Mount the shocks onto Legend Lift Plates using the proper bolts and spacers sequence. Tighten to the appropriate torque spec for your shock configuration. (Stock Shocks: 70 ft/lbs) (Legend Shocks: 50 ft/lbs)
- F. Raise the jack and mount the shocks to the sub-frame using the proper bolts and spacers sequence. Tighten to the appropriate torque spec for your shock configuration. (Stock Shocks: 70 ft/lbs) (Legend Shocks: 50 ft/lbs)
- G. Install the two bolts in parking brake bracket and tighten to a final torque of 45 ft/lbs. FIGURE A & E
- H. Lower and remove jack from under the trike.
