### **OVERVIEW:**

Thank you for choosing a Saddlemen Road Sofa for your Harley-Davidson Touring motorcycle. We hope you'll agree that this is the finest, most comfortable seat you'll ever ride on. It's Saddlemen's goal to make the best seat we can, using only top grade materials and carefully refined contours to provide the most comfortable ride possible.

Seat options that are covered by these instructions include: Removable, adjustable Driver's Backrest; Seat Heater, and Rain Cover.

### **IMPORTANT:**

Please read these instructions completely before starting installation. All "NOTE," "CAUTION" and "WARNING" notations are serious safety issues and should be read carefully. Possible injury to riders or damage to the motorcycle and/or accessory may result if improperly installed.

# **NOTICE TO DEALERS:**

These instructions contain important information for future reference and should be given to the customer.

# A WARNING:

#### READ ALL INSTRUCTIONS THOROUGHLY BEFORE STARTING!

Because of the variety of motorcycle configurations, other accessories, and the features and intended use of this Saddlemen seat, there may be different mounting options. You are responsible for the proper installation of this seat on your motorcycle. Your attention to these installation instructions, any additional specific instructions and recommendations will permit the safe and proper use of this seat. You must mount this seat properly and securely before riding your motorcycle. If you lack the ability to safely and properly install this seat, seek out a qualified motorcycle technician for assistance. During installation, you may need to support the motorcycle with a suitable stand or lift so it will not tip over and injure you, or damage the vehicle. Using or mounting this seat improperly could result in a loss of control of the motorcycle which could result in damage to your motorcycle or other personal property, the property of third parties, and/or personal injury to yourself or others, up to and including death.

PASSENGER GRAB STRAP: This accessory seat is provided without a passenger grab strap. Carrying a passenger without a grab strap in place on your motorcycle may be hazardous for the passenger. Grab straps, rear mounted foot pegs, sissy bars, passenger backrests and trunks aid in making a passenger more secure on the vehicle. Laws in some jurisdictions require grab straps or other security devices when a passenger is transported. Do not transport a passenger if they are not secure. Do not disable grab straps or other safety features provided on your motorcycle and obey all traffic laws while riding.

Saddlemen offers a complimentary grab strap for this seat, part no. 15327. Call (310) 638-1222 for more information. Always ride responsibly and take precautions to be sure your passenger is secure and comfortable at all times.

- The seat must be installed and securely fastened onto the chassis of the motorcycle. Refer to your motorcycle's Owner's Manual and/or Service Manual for guidance.
- If you do not understand these instructions D0 NOT mount the seat, and remove any related components you may have already installed on your motorcycle.
- Thoroughly inspect your motorcycle's seat before every ride. Do not use this seat if its mounting system has been modified, has deteriorated, loosened or is beginning to fail.
- Continually check the security of your seat and other accessories at each stop as you ride. Items attached to your motorcycle can loosen during operation, so be sure to check them frequently.
- Do not use this seat if you have any doubts as to whether it is properly mounted to your motorcycle. You must be sure that the installation of the seat will not damage your motorcycle's painted or plated parts. Saddlemen is not responsible if you or your technician mount the seat and it damages your motorcycle for any reason.
- When using any accessory, do not exceed your vehicle's Maximum Gross Vehicle Weight as listed on your motorcycle or in the manufacturer's owner's manual.
- If your seat is ever damaged, do not use it until it has been inspected by your local professional motorcycle dealer. You may also need to send your seat to Saddlemen for inspection or repair. Replace any mounting part immediately if it has sustained damage that will prevent the seat from being properly secured to your motorcycle.

# A WARNING:

Remember: Motorcycling can be a dangerous activity. Installation of any accessory can increase your risk if it is not installed properly. Seats with heaters require that the battery terminals be disconnected in advance, before working on the motorcycle's electrical circuit. When appropriate, the security codes (radio, navigation system, etc.) should be noted.

#### SEAT HEATER USE WARNINGS

• Seat heaters must not be installed on motorcycles that will be used by riders who cannot sense heat and/or are sensory compromised, due to a risk of thermal burns.

• If you install any luggage or bags onto the passenger seat, you must turn off the passenger seat heater, due to a risk of damage to your luggage or seat.

## INSTALLATION:

To avoid injury, install while engine is cold.

1. See Fig. A. Remove your stock seat with a single screw, located on the rear fender behind the seat. You may also need to remove the passenger grab strap. If your bike is equipped with seat heaters, you may need to disconnect some wires as you pull the seat off your bike.

2. See Fig. B. Some Saddlemen seats will have the rear metal seat tab installed backwards for shipping; using a 4mm Allen wrench, take off that tab and reinstall it in the correct position for mounting on the bike.

3. When installing your new Road Sofa, you may need to apply downward pressure as you slide the front of the seat towards the gas tank, engaging the front seat tabs under the bike's frame.

4. Once your new seat is in place, Saddlemen provides a protective washer to put between the metal seat tab and your fender, as you reinstall the seat screw.

5. **2014** and later H-D Touring models have two metal frame bumpers on either side of the battery (see Fig. C) that should be removed prior to installing your Saddlemen seat.

6. *Some H-D CVO Touring models* may have come with trim pieces installed on top of the rear fender (see Fig. D). Some Saddlemen seats will not be compatible with these fender trim pieces. If the trim pieces interfere with the installation of your new seat, you'll need to remove the trim pieces, which are glued to the fender with adhesive tape. Use a paint-safe adhesive remover product, or a hair dryer to heat up the adhesive and make fender trim removal easier.

## INSTALLATION (continued)

#### **OPTION: REMOVABLE BACKREST - ADJUSTMENT AND OPERATION**

If your seat was ordered with the Driver's Backrest option, there will be hardware inside the seat to receive the backrest bar (note that this will not work with any fender-mounted backrest installation). Access is through a slot (sometimes covered by a flap) on the seat top behind the driver's lumbar support. The metal backrest bar will get inserted into this sleeve and can then be adjusted both vertically or fore and aft.

Your backrest may have come pre-assembled. If so, please skip ahead to #2.

1. ASSEMBLY Remove the loosely assembled bolt, washers and nut. Find the Backrest Bar and assemble it to the Backrest Pad by inserting the end of the bar with the welded tubing into the chrome "C" bracket found underneath the pouch on the rear of the backrest. Re-install the bolt, washers and nut. The fore/aft adjustment screw on the bar should be facing forward on the bike. Slide the soft vinyl backrest bar cover sleeve over the bar, bringing the thumb screw through the hole in the cover sleeve.

2. INSTALLATION Grasp the backrest bar and slide it into the hidden metal sleeve. You should feel it click into place. If the backrest bar is "floppy" after insertion, it is not inside the metal sleeve. Remove and reinstall, making sure it is firmly in the correct position.

3. ADJUST HEIGHT The height of the backrest is adjustable to two or three positions, determined by detents on the backrest bar. Adjust height by firmly grasping the bar and lower or raise it to the desired height.

4. ADJUST FORE/AFT POSITION The fore/aft position of the backrest unit is adjusted by a thumb screw located under the backrest pad on the backrest bar. It is accessible through a hole in the backrest bar cover. Turning the screw in or out, will change the bar angle. This can slant the pad fore or aft by three inches. The most common and suggested starting position is with the backrest aligned directly above, and at the same angle as, the upward portion of the driver's lumbar support. When you have adjusted the backrest to the desired angle, using a separate open end wrench, tighten the included jam nut against the backrest bar to prevent the screw from backing out while riding.

5. ANGLE The backrest pad is designed to automatically conform to the angle of the driver's back during riding. No adjustment is necessary.

6. REMOVAL Grasp the backrest bar. Pull it firmly up and away from the seat.

7. FOLDING The backrest can be folded forward by pushing the top of the backrest forward. This will assist passenger boarding.

8. TENSION The tension of the folding process and the angle adjustment can be changed as desired. Tighten or loosen the two horizontal bolts passing through the backrest bar at the hinge and backrest pad attachment points.

#### **OPTION: TRUNK MOUNTED PASSENGER BACKREST PAD**

Saddlemen offers passenger backrest pads to match every Saddlemen Road Sofa style. Each is a direct replacement pad that mounts to your Tour-Pak. Ask your dealer or call a Saddlemen sales rep at 310-638-1222 for more details.

#### **OPTION: RAIN COVER**

Slip the cover over the seat, using the elastic edging to keep it in place. The cover is designed to fit over the optional driver's backrest. The Rain Cover is only intended to be used when the motorcycle is parked, not while riding.

## INSTALLATION (continued)

#### **OPTION: SEAT HEATER**

The seat heater option will require you to connect wires from the seat to the motorcycle. Saddlemen provides a wiring harness with a quick-disconnect plug that makes it easy to remove your seat in the future. Motorcycle electrical systems can be easily damaged if you are not experienced. If you have doubt as to your ability to safely install this accessory without damaging your motorcycle, please consult with a qualified motorcycle technician.

**NOTE** When removing your heated seat from your motorcycle, always make sure to also remove the wiring harness.

#### For H-D Touring models 2014-2023

1. Turn key or ignition switch to OFF position and remove key. If equipped with keyless fob, remove fob from proximity of vehicle.

2. With the seat off the bike, begin by disconnecting both terminal leads to the battery. 3. Under the motorcycle's left side cover is a plastic, triangular shaped housing for electronic components (see photo). With a 1/2" socket wrench, remove the two top bolts that hold the housing to the frame (A). You will only need to pull the housing away from the bike an inch or two, so there is no need to disconnect wires.

4. From the left side of the bike, run the wiring harness power connector plug, as well as the black ground wire, through the center opening of the component housing (B) and under the frame rail, locating them near the battery. The seat's red power wire should stay outside of the triangular housing, near the fuse box. The black wire should be above the battery.

5. Unclip the motorcycle's ECM computer, and attach the heater's black ground wire to the battery's negative (-) terminal. Re-clip the ECM back in place.

6. Remove the stock fuse box cover (C), and pull out the top middle 7.5 fuse. The Road Sofa's red power wire has a special fuse tap that mates with the LEFT SIDE of the 7.5 amp fuse (D). With the fuse tap in the left side of the fuse, push the fuse back into place. Replace the fuse box cover with the new, taller cover included with your seat, which features an open slot through which you can run the red seat heater wire.

7. Once you've got the wiring in place, reconnect the battery terminals.

8. Reinstall the side cover and the seat.

#### For H-D Touring models 2008-2013

1. With the seat off the motorcycle, begin by disconnecting both terminal leads to the battery.

2. On the motorcycle's left side, open the fuse box cover.

3. Pull out the 15a Accessory fuse (see your owner's manual for its location). The seat heater's red wire has a fuse tap (Fig. D), that mates to this 15a fuse. Once you've reinstalled the fuse with the fuse tap, replace the stock fuse box cover.

4. Attach the heater's black ground wire to the battery's negative (-) terminal.

5. Reconnect the battery terminals.

6. Reinstall the side cover, and the seat.

#### For H-D Tri-Glide models

Option A: Attach the seat heater negative (black) wire to your trike's negative battery terminal. Attach the seat heater power wire (red) to your battery's positive terminal. Using this method will power the heater at all times, which will require you to turn off the heaters each time you finish riding. Option B: Visit your local motorcycle dealer for help with a plug and play adapter for your Tri-Glide.

#### **BREAK IN AND MAINTENANCE**


Allow a brief break in period for the Saddlemen seat to conform to your anatomy, and for you to become accustomed to a "new feel". This should be accomplished within your first 500 to 1200 miles. NOTE: Due to the firmer foam used in a Saddlemen, your new seat will feel slightly higher at first. Your Saddlemen seat will gradually break in to your anatomy and slightly compress as your mileage increases. It does not breakdown like a factory seat.

### **CAUTION:**

It is your responsibility to make sure the seat installation does not create an unsafe or illegal situation. Remember that this seat is a custom accessory. It is your responsibility to check the installation to determine if it will be safe for you to operate the motorcycle and to properly and safely carry a passenger (this includes reinstalling the passenger grab strap or installing a suitable replacement). You must also ensure that the installation does not damage your vehicle in any way.

After 50 miles (80 kilometers), recheck the seat's mounting to make sure it is still secure. Inspect all of your accessories and related hardware before and during each ride. An improperly mounted seat can interfere with the vehicle's operation and cause an unsafe riding condition.

Always carefully check fitment before the final mounting of your new seat. DO NOT bolt down the seat until you confirm it fits properly. When checking fitment of your Saddlemen seat, place a cloth under the seat then carefully set the seat on the bike and confirm fitment.
