Under this warranty, SuperTrapp will repair or replace defective, covered parts, at option, or provide a replacement unit. SuperTrapp makes no warranty with respect to components of the SuperTrapp product not manufactured by SuperTrapp, including, but not limited to the following: clamps, nuts, bolts, packing, boots and hoses. Repair by SuperTrapp or replacement are the exclusive remedies under this written warranty or any implied warranty. SuperTrapp will not pay for the cost of removal or reinstallation of the unit from any vehicle or for delivery and pick up of the unit. To obtain service under this warranty, the original purchaser must give specific written notice to his or her dealer within fifteen (15) days after discovery of any claimed defect in the unit, and must return such unit to the dealer within a reasonable time thereafter at the cost of the original purchaser.

This limited warranty is the only express warranty applicable to SuperTrapp product. Any implied warranty of merchantability or fitness for a particular purpose is limited in duration to the duration of this written warranty. Installation Instructions

!!!! IMPORTANT !!!!

Installation of this product on your motorcycle will require the use of an aftermarket air cleaner housing. We found that the stock air cleaner housing extends too low and interferes with the front head pipe. Any air box with a smaller outside profile is acceptable. This includes the Screamin'Eagle High Flow kit for the stock air box (pictured below).

REMOVAL OF STOCK SYSTEM:

- 1. Remove the stock exhaust system as described in your service manual. Retain the flange nuts for the new system installation.
- 2. Remove the stock snap rings and flanges from the head pipes and retain for the new system installation.
- 3. Remove the oxygen sensors from the front and rear head pipes and retain for new system installation.
- 4. The exhaust gaskets should be replaced to achieve a proper fit and seal. Replacement gaskets are available from your Harley-Davidson dealer, part number 65324-83A.


SYSTEM INSTALLATION:


- 1. Install stock flanges on both head pipes.
- IF USING 18mm OXYGEN SENSORS, REMOVE ADAPTORS FROM THE FITTINGS IN THE PIPE (See Figure 1).
 Apply a very light coating of anti-seize to the threads of the oxygen sensors and install in the new head pipe. (CAUTION: Apply anti-seize to the threads of the oxygen sensor ONLY. Contamination of the sensor probe can adversely affect engine performance.)

NOTE: The oxygen sensor connectors are color coded for proper installation. The GRAY connector is for the FRONT sensor and the BLACK connector is for the REAR.

- 3. Remove the decorative clutch cover from the transmission. (See Figure 2)
- 4. Remove the lower two transmission side cover bolts and install supplied transmission mount bracket in that location re-using the stock bolts (See Figure 3). Center the slots in the bracket with the heads of the bolts and tighten to 13-18 ft-lbs (17.6-24.4 Nm)
- 5. Re-install the decorative clutch cover.
- 6. Install the (2) supplied T-bolts in the slide bracket on the head pipe collector.
- 7. Mount the head pipe using the stock flange nuts. Align the T-bolts with the holes in the mount bracket as you seat he head pipe in the exhaust ports. Align the flanges at the port and install the flange nuts. **DO NOT TIGHTEN**.
- 8. Install the supplied flat washers and lock nuts on the T-bolts. **DO NOT TIGHTEN**.
- 9. Tighten the head pipe starting at the ports. Tighten ports evenly, alternating from front to rear. Finish by tightening the T-bolts at the collector.
- 10. Reconnect the oxygen sensors to the wiring harness.
- 11. Clean the pipe thoroughly to remove oil and finger prints before starting. Failure to clean the surface thoroughly may result in permanent stains in the surface. A high quality glass cleaner is ideal for this task.

IMPORTANT: CHECK AND RETIGHTEN ALL FASTENERS AFTER THE FIRST RIDE. RECHECK AT EACH SCHEDULED MAINTENANCE.





END CAP ADJUSTMENT:

The Bootlegger head pipe is supplied with a Turn Down/Out end cap. The cap is installed as a Turn Out at the factory. To change position to a Turn Down, remove the (3) button head screws on the collector and rotate the cap downward until the cap holes line up with the collector holes. Re-install the (3) button head screws to finish the change.

TUNING TIPS:

This system was designed to perform using a free-flowing air filter kit with a stock tune. Additional performance gains could be achieved with additional tuning. This work should always be performed by a qualified technician.

We DO NOT suggest removing the muffler packing material to "get more noise". Removing the packing will result in a loss of power, discoloration of the muffler finish, and potential failure of the mechanical core components.

CARE AND MAINTENANCE:

This pipe is supplied with cleaning pads that can be used to remove burned-on substances and return your pipe to the original finish. Rub these pads radially, around the pipe, to achieve the original factory finish.
