



## **TOOLS REQUIRED**

### **BAFFLE REMOVAL AND INSTALLATION**

- 1. Remove the end cap. The end cap is held on by two 5/16-18 button head screws located on the bottom side of each muffler body (**Figure 1**).
- 2. Once the screws have been removed, remove the end cap and baffle as a unit.
- **3.** After removal of the end cap/baffle assembly, locate the (3) 10-32 cap screws that retain the end cap to the baffle. Remove end cap screws from the baffle and discard them (**Figure 1**).
- 4. Install the end cap onto the new baffle using (3) 10-32 cap screws provided.
- **5.** Reinstall the end cap/baffle assembly. Carefully make sure the baffle end is properly aligned into the muffler body inlet tube.
- 6. Reinstall the two 5/16-18 button head bolts, use blue loctite #243 on all bolts.
- 7. After installation and before starting motorcycle, completely clean pipes and mufflers with warm, soapy water and a clean, soft cloth that will not leave a residue. Note: Any residue, oil, or fingerprints will stain the finish when the metal heats up.
- 8. Be sure to tighten all hardware before starting your motorcycle.
